1 For computers with more than four (4) cores (CPUs) a Standalone Lock will place on hold the 5th, 6th, 7th, etc simulations. For computers with more than four cores Multi-Core Standalone Locks are available or can be upgraded to allow more than four simulations at once. Multi-licence standalone discounts do not apply to Multi-Core Standalone Locks.
